In addition to managing charitable contributions on behalf of donors, the Mt. Pleasant Area Community Foundation serves Isabella County through the awarding of grants to charitable organizations totaling \$538,468 and scholarships to students totaling \$127,100 in 2021. The Community Foundation's largest grants in 2021 were awarded to the Mount Pleasant Discovery Museum, Issue Media Group, and MidMichigan Health Foundation.
